#### History of the LPS Education Foundation

Nearly two decades ago, the financial situation of the Livonia Public Schools was radically different than today. At that time, the district was experiencing increasing enrollments, the state and national economy were robust, and the negative impact of an economic downturn was yet to be felt.

In 1997, the Board of Education commissioned a feasibility study to be conducted regarding the establishment of a school district foundation. Neighboring school district foundations were surveyed, research was gathered and analyzed, and consultants provided advice. After reviewing the results, the Board of Education decided against establishing a foundation at that time.

In late 2002, a follow-up study was conducted, at which time conditions had changed drastically and the need for an independent funding source that might aid the district, was seen as both feasible and necessary. The following year, events were set in motion that resulted in the formalization of the Livonia Public Schools Education Foundation in early 2004.

First, all the documents required to legally establish a foundation needed to be written and submitted, including Articles of Incorporation, By-Laws, application for 501(c)3 status with the IRS, and other legal documents.

Next, a Board of Directors was selected and agreed to serve. The officers were elected for positions of President, Vice President, Secretary, and Treasurer.

Board members developed a mission statement, guiding principles, core values, goals and objectives, logo design, an information dissemination process, fund-raising strategies, and a host of other necessary tasks.

We have joined a national movement that is growing every year. According to the National School Foundation Association, \$31.59 million was donated to education in the U.S. in 2003, the second largest recipient category (behind religion) of philanthropic donations in the U.S. It is projected there will be an intergenerational wealth transfer occurring over the next 25-35 years, yielding between 15 and 40 trillion dollars. The Giving USA 2001 reports that many major donors who give to education are switching their financial support and focus from college and universities to elementary and secondary schools, and are finding educational foundations an excellent way to do that.

Commencing in Fiscal Year 2008, the Foundation initiated The Competitive Edge College Savings Program, which encouraged parents of new first graders to establish a college savings (529) plan. Starting in 2010, due to the overwhelming response from parents who are anxious to set up a college savings plan for their children at an early time, the Foundation offered the Competitive Edge program beginning with students who enter kindergarten. The Foundation provided an initial amount in a holding account for each kindergarten student whose parents registered for the program during this fiscal year.

With these facts in mind, and the firm belief that our teachers and administrators are committed to providing a high quality education for our community's children, we believe the growth and development of the Livonia Public Schools Education Foundation will play a vital role in the continued excellent educational experience offered to the Livonia Public Schools students.

We have a dedicated and talented Board of Directors, energetic and hard-working volunteers, and great partnerships with the business community. However, we have much to do.

We are grateful to all who have contributed time or money to the Foundation this year. We are optimistic about the future, and ask you to join us in teaming together to ensure learning for all.

## Support continues for Competetive Edge College Savings Program

The annual fundraiser luncheon to support the LPS Education Foundation's Competitive Edge College Savings Program was again a huge success, drawing more than 230 supporters to the Nov. 8 event at St. Mary's Cultural and Banquet Center.

From business and education to faith and non-profits, it was a tremendous show of support, according to LPS Education Foundation President Diane Policelli.

"It is a tribute to our community and to the LPS Education Foundation that you have filled the room to show your support," said Policelli.

Luncheon chairman Jay Young said several people have commented that this is a "must attend" event, each year, because it serves as a major source of funding for the Foundation's Competitive Edge College Savings Program.

The Foundation offers a college savings trust account to each participating kindergarten student in LPS, with an initial deposit made by the Foundation and additional contributions being added by the Foundation, each year, as budgets allow. Once the student graduates from LPS, he or she can use the accumulated funds toward a college, trade or any other post-secondary program, anywhere in the nation.

Since the Competitive Edge program began in 2008, the Foundation has set up savings accounts for nearly 2,500 students and has donated almost \$350,000 to the students' accounts. For the current school year, the Foundation added 420 students to the program.

The eighth annual luncheon is the main fund-raising event for the program, and always features "outstanding" guest speakers, noted Young.

This year, Crain's Detroit Business editor and publisher Ron Fournier offered stories from his political reporting career and political insight into today's local and national landscape. The Detroit native is an award-winning and critically acclaimed political contributor to The Atlantic, who started his career in Arkansas. covering then-governor Bill Clinton, before moving to Washington



DC to cover the politics and the presidency during the administrations of Clinton, George W. Bush and Barack Obama.

Each year, hometown favorite, Steve Courtney, WJR sports director, serves as host and emcee, offering a dose of humor to the event.

#### Competitive Edge College Savings Program

The goal of the Livonia Public Schools Education Foundation is to provide a unique opportunity for LPS parents to begin planning for their children's post-secondary education early on, and help set aside money for their future educational expenses.

The Competitive Edge Savings Program offers families of LPS kindergarten students the opportunity to enroll in this free program and the Foundation will designate them as beneficiaries of the Foundation's educational savings account. The Foundation contributes seed money and those funds grow throughout the child's LPS educational career. Upon graduation from LPS, the funds may be used for any post-secondary education or skills training program. Currently over 2500 students are enrolled.

Not only does this program provide a great service to LPS students and their families, the Foundation also sees this as an added benefit to attract and retain families in the community. This unique program can help maintain the vibrance of our community and consequently, each family it attracts brings state funding to the school district, meeting the foundation's mission "to enlarge the resources available to the school district which will foster and expand educational opportunities."

It truly can provide a "competitive edge" over our surrounding communities.



## Grant program thriving in LPS

The LPS Education Foundation's grant program is in its fifth year, and has distributed 85 grants totaling \$183,000 to LPS classrooms, schools and departments. Each year, LPS teachers and non-instructional staff may apply for a Foundation grant to fund a special project, equipment or other needs that may be outside of the district's budget.

A grant committee reviews the applications and selects which requests will be funded. A group of grant committee members recently paid 24 staff members a surprise visit, with over-sized checks in hand.

"This is a wonderful gift from the Education Foundation that we are very proud of," said LPS Education Foundation President Diane Policelli. Grants are funded, in part, by staff donations, which are matched by the Foundation. A Champions program was established to ensure staff awareness and to help generate and maintain financial support for the program. Additional donations for the grant program are made by corporate and individual donors.

The Foundation also operates a literacy program, which provides one-onone or small group literacy tutoring for elementary school students. The program enables retired LPS staff members the opportunity to continue to make a difference in students' lives.


